ELM BROOK HILL, PARKER'S REVENGE & TOWER PARK


13 April 2024

The Regiment will appear under the command of Lieut-Col Michael Graves for the Battle Road Events on Saturday 13 April 2024.

Travel is by private vehicle. Car-pooling is recommended.

Uniformed Soldiers: Arrive no later than 10:00 hrs. Parking for uniformed soldiers is at Lincoln North, 55 Old Bedford Road, Lincoln, MA (see map).

Civilian Evacuees: Arrival no later than 08:30 hrs. Parking is at the Hartwell Tavern Parking Area Annex or the Paul Revere Capture Site (see map). Those evacuees joining the procession at the Josiah Nelson House site will park at Paul Revere Capture Site and register with the Battle Road Guides at Minute Man Visitor Center between 11:00 am and 12:00 pm.



Dress for uniformed soldiers shall be No. 2 for all ranks: short gaiters, natural wigs, canteens filled with water, haversacks on top of belting. Officers may wear shoes and gaiters in lieu of boots. All firelocks are to be equipped with flints, flash guards and hammerstalls as there will be firing. Dress for Civilian Evacuess shall conform to the Park's standards. **Wool small clothes for soldiers are required for participation.**

Upon arrival, uniformed soldiers should make their way to the Elm Brook Hill (*aka* Bloody Angle) area registration site (see map), Civilian Evacuees to Hartwell Tavern or the Smith House as assigned by the civilian organizers.

Crown Forces schedule

- 10:00 11:00 hrs: Registration open
- 11:15 hrs: Arms inspection and ammunition distribution
- 11:45 hrs: Engage militia, Elm Brook Hill to Samuel Hartwell
- 12:15 hrs: Scenario ends
- 12:20 hrs: March to Paul Revere capture site
- 13:00 hrs: Engage militia, Parker's Revenge to Bluff
- 13:20 hrs: Clear weapons, collect ammunition (NPS staff)
- 14:30 hrs: Board buses to Tower Park / Munroe Tavern. Buses will make a brief stop at the Lincoln North parking area before returning to Fiske Hill (Parker's Revenge end site) to pick up more reenactors.
- 15:00 hrs: Arrival at Munroe Tavern.
- 16:00 hrs: Tower Park Battle scenario, Lexington, MA.
- 17:00 hrs: Scenario ends, board buses for return to Lincoln North parking site.

Civilian Evacuee schedule

- 9:30 hrs -11:00: Hartwell Tavern open
- 9:30 hrs 11:45 hrs: Smith House open
- 11:00 hrs: Hartwell closes and NPS staff begin to lock area down
- 11:00 hrs: Evacuee program starts at Smith House
- 11:45 hrs: Evacuation of Hartwell Tayern
- 11:55 hrs: Evacuation of Smith House
- 12:30 hrs: Brief rest at Nelson House
- 12:45 hrs 13:00 hrs: Evacuees process along route of demonstration area. First person, no interaction with Guides or visitors. Evacuation of family via oxcart from Whittemore House.
- 13:00 hrs: Exit demonstration area at the Bluff.
- 13:30 hrs: Picnic lunch

Note that there is much going on this day and the above schedule will be "fluid." Thus, we ask all members to remember our Regimental motto "*Be flexible!*" and act accordingly.
