**Meeting called to order 7:35PM**

- I. **Opening Remarks (Graves):** Mike Graves thanks everyone for a great weekend, and really appreciates all the work around the camp. The Duty Roster is working very well and people helped everyone else pack up at the end of the event. OSV thought the event went well, with 8300 visitors over the two days. We have just over 1800 rounds left. We've used 1700 rounds since Bunker Hill. We only want to take enough powder to use for St. Jean and not much more.
- II. **Meeting minutes, July 16, 2025: APPROVED**
- III. **Recruiting committee updates (Falotico)**
  - a. Spoke to two people at OSV: A middle-aged man from Longmeadow, MA, and another who is in his early 40s and serves in the USMC
  - b. Emailing another man (~26 years old) from Boston area
- IV. **Paymaster updates**
  - a. Total \$22,000 (approx.) today
  - b. No major outstanding bills
  - c. Some people owe money to The Regiment but invoices will be going out
  - d. New insurance summary sheet should be coming
- V. **Quartermaster Updates**
  - a. \$4,200 was approved to buy materials; Able to secure items like lace, black horn buttons, etc.
  - b. Discussed madder red bolt with Najecki, and ordered more buttons
  - c. Canteens have been coming in leaky
    - i. Richard Eckert is the former tin smith at OSV and mends canteens
    - ii. Open to tin if we can make sure there is an effective way to prevent rust
  - d. Was able to get the new Sandford's Co'Y recruit outfitted for OSV

- f. Match cases have been delivered
- g. Tentsmith is having trouble filling tent orders
  - i. another option is the Maryland Sutler
- h. Morgan Gabrenas has been making shirts
- i. Future supplies
  - i. Conduct analysis of supply and demand for new recruits to figure out on where we need to stock up
  - ii. Lenny purchases enough supplies for recruits plus a little extra
  - iii. Need to consider lead team and items that need to be custom-made
  - iv. Hear from Tyler Viger to see how he what he can put together

#### **VI. St. Jean**

- a. Paul will keep sending info to Dylan so that he can draft Orders, as well as a letter and forms for crossing the border
- b. Divide up powder amongst serjeants to make sure any one person doesn't cross with too much
  - i. Mike needs to know how many firing muskets, so he can pack the appropriate amount of powder
- c. 2 scenarios on Saturday, 1 scenario on Sunday – break camp by 3PM
- d. Taking kitchen items (no trailer transportation)
  - i. Take tripod
    - 1. Cooking will be on top of plates
  - ii. Likely 25-30 people going – Dylan will send out meal link and request people to take kitchen items
