    - i. The Regiment is down to 8 cyphers, would like approval to order more
      1. \$360 for 12 cyphers – Expenditure APPROVED
  - c. Paul has a musket for Noah, and Mike will make a sling
  - d. Roy Najecki has set aside a bolt of madder red wool, will be casting enlisted buttons
    - i. If Roy retires, can we acquire the button molds?
  - e. Lenny has procured more linen for shirts from Waltham store

    - i. Paymaster's Report attached
    - ii. Contacted to St Brigid's to secure the drill hall for drill and 4 Saturdays for recruit school
    - iii. Invoices were issued today

      1. 2024 – Took in approx. \$9,800
      2. 2025 – Lost Lexington & Concord parades but did extra events, resulting in \$12,000
      3. 2026 – Not sure about Lexington & Concord parades in 2026. Projected income down to \$7,000

- ii. Renewal package for Liability – Legal defense costs will be included in the liability limit. This will affect the \$1M liability limit if defense lawyer costs are included
      - 1. Quote for \$1M general liability - \$940.76/year
      - 2. Approx. \$3300 for insurance per year total (trailer, colours, etc)
      - 3. \$2M liability adds approx. \$525/year to current amount
        - a. Motion to increase policy: APPROVED

  - a. Supplies Tracker
    - i. Tyler V has started production
  - b. Powder Party
    - i. Scheduled for September 14<sup>th</sup>, 10 AM, at Graves' residence
  - c. Gloucester 2026
    - i. Have \$50,000 to start and have other donors in line
    - ii. Town on board
    - iii. 10<sup>th</sup> will not spend money on it
    - iv. June 20<sup>th</sup> weekend
- VII. Drill Schedule discussion
  - a. Focus on musket handling during winter months
  - b. Have NCOs review the manual to be consistent
  - c. Potentially mix companies during future drills

  - a. Isaac would like to open it up to whole Regiment
  - b. Jon Demler knows someone who has an AirBnb on a large track of land
    - i. Can accommodate more people
    - ii. More money (approx. \$1500 to rent)
      - 1. YouTube Channel will contribute some capital
      - 2. Remaining costs will be divided among participants
      - 3. Is the Regiment willing to offer financial support
